19.20 Welcome and Public Session.

The Chairman welcomed members, partners and the nine Parishioners present to the meeting and invited any comments or concerns to be raised. In doing so indicated that an additional fifteen minutes would be allowed for at his discretion under standing orders if required.

One Parishioner raised a later agenda item on the glebe field, members agreed to a site visit with St Peters Church representatives to discuss and report back to the next meeting on the potential of restoning a section of the field for parking.

Two other Parishioners raised their individual planning applications with the Parish Council. Members noted all the comments made and indicated that a planning committee meeting would be scheduled for Tuesday of the following week. The comments already made would therefore be taken into account on the two applications and the Parishioners would be able to attend but not speak.

Flight Sergeant Wood from RAF Shawbury indicated that the main item to highlight with the Parish Council was that of night flying and that the flying school was very busy at present. An issue of noise was raised in connection with Cheswardine Farm and the Flight Sergeant agreed to investigate. In terms of community projects the support for Dutton Close Residents Association had been agreed and the second request for the planting of a wild flower meadow at Riverside Drive is being processed.

23.20. Clerk Report.

- iii. Ollerton Lodge to Peplow Chapel public bridleway: the Planning Inspector has ruled in favour of the Parish Council and has given Shropshire Council six months to resolve the situation. Members agreed this case should be publicised through SALC.

 - 1. <u>20/01317/FUL New Entrance to Affordable House North of Blossom View</u>: **No Objection**
 - 2. <u>20/00126/EIA</u> <u>Proposed Additional Egg Laying Units at Ollerton Park:</u> Object. The Parish Council wish to maintain their objection to the Application, given that admittedly more extensive tree planting proposed is unlikely to provide sufficient mitigation for the scale of these buildings within the landscape. The Parish Council also support the request from Historic Environment for an image of the development from the diverted footpath to Peplow Hall. However should Shropshire Council be minded to grant this Application the Council would wish to see a more detailed Planting scheme, to include using larger stock, to assist the screening effect and additional protection for the trees that are proposed as those already planted on the site have been damaged and need replacing.
 - 3. 19/05437/FUL Re-submission of Proposed Residential Development of Rosehill Road: Object. The Parish Council recognise that the Applicant has gone some way to improving the aspect of this development, and we are grateful to see that the mature tree and the majority of the hedges on the site are to be retained, but we still feel that the house will sit uncomfortably within the local street scene due to its substantial size and height, and that it would be of benefit to see an assessment of the impact of this large house in comparison with other properties in the vicinity. Although the roofline has been lowered it is still markedly higher than any comparable roofs and the revised elevations emphasise this as it is now shown with gables to the north and south. The drawing is also incorrectly orientated and the proposed solar panels are in fact located on the eastern roof rather than a south orientated one. This can easily be confirmed by viewing the panels on the nearby properties
